

# ENERGY EFFICIENCY REBATES

## PART OF ALBERTA'S CLIMATE CHANGE PLAN



### HELPING ALBERTANS DO THEIR PART TO CONSERVE ENERGY

The Alberta government is investing \$36 million over three years on energy efficiency rebates to help Albertans reduce how much energy they use in their day-to-day lives.

### REBATE PROGRAMS

The consumer rebate programs are available to homeowners, new home buyers and taxi operators to offset the cost of making energy efficiency improvements. Eligible purchases are retroactive to January 1, 2009.

WHAT'S ELIGIBLE	REBATE VALUE
New homes <ul style="list-style-type: none"> <li>• must achieve an EnerGuide efficiency rating of 80 or higher</li> </ul>	\$1,500-10,000
High efficiency heating systems <ul style="list-style-type: none"> <li>• includes furnaces and boilers</li> </ul>	\$400-600
Clothes washers <ul style="list-style-type: none"> <li>• all ENERGY STAR® clothes washers</li> </ul>	\$100
Insulation <ul style="list-style-type: none"> <li>• upgrading insulation based on federal ecoENERGY home evaluation</li> </ul>	Up to \$3,150
Hot water heaters <ul style="list-style-type: none"> <li>• energy efficient models based on federal ecoENERGY home evaluation</li> </ul>	\$250-300
Home energy evaluation <ul style="list-style-type: none"> <li>• federal ecoENERGY home evaluation</li> </ul>	\$100 pre-retrofit evaluation \$100 post-retrofit evaluation
Taxi owners and operators <ul style="list-style-type: none"> <li>• gasoline-electric hybrid vehicle (retroactive to July 1, 2008)</li> </ul>	Up to \$3,000

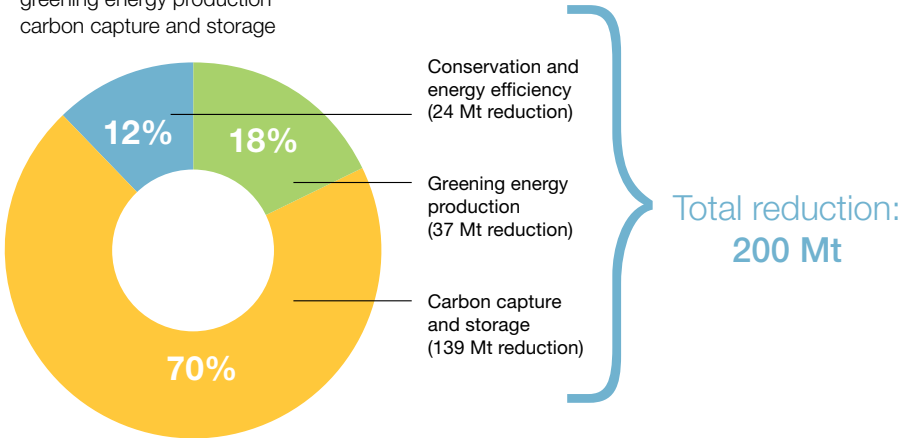
